Nineveh Charitable Trust Grant and South Cumbria Rivers Trust

Grant: £4950 March 2022 – March 2023

The funding from the Nineveh Charitable Trust contributed to the part-time role of the Communities & Engagement Officer, ensuring that communities and schools continued to be involved in our work. The funding also provided staff support to some of our water quality monitoring volunteers.

Working with Schools

We were able to work with 5 additional schools, including a class from the SENS unit at Queen Katherine's High School, Kendal.

All activities looked at freshwater ecosystems, learning about rivers and their associated habitats and species, and the impact people have on them.

We were able to support class work on the decline of water quality in rivers and lakes and what work can be done to help restore them. Invertebrate sampling was enjoyed by all and helped develop the understanding of healthy ecosystems, food chains and interdependence.

Community Engagement

We held a series of 4 community events in August 2022, including one in partnership with the Brantwood Estate. The events were to encourage people to learn more about freshwater habitats and species.

45 adults and children attended in total, which was less than anticipated but the weather was poor for two of those events.

A family that attended one of the events passed on contact details to their children's school (Goodly Dale). From this we were able to deliver a learning session for two classes at the school in the Autumn term.



The funding also supported staff attendance at two community events: Kendal Torchlight and Clean River Kent Campaign Open Day.

We had a stand at each that focussed on the Kent catchment, it's designation as a Special Area of Conservation, key species of critically endangered freshwater pearl mussel and white-clawed crayfish and upcoming restoration work. Number of people engaged: 130



Working with Volunteers

The funding also covered some staff time to support a team of volunteers who carry out monthly water quality sampling around the Coniston catchment, increasing data and knowledge about the becks and lake, water quality and freshwater habitats.
