Tell us about the Funds

- Has the project we helped to fund been completed? If so, how is it maintained?

Our Guildford Youthscheme is an ongoing project that runs on Saturdays as well as during school holidays (including half term) and does not have an end date. It is maintained through funding from Surrey County Council, parental contributions and a sustainable voluntary income model.

- If not completed yet, why not? Are plans in place to finalise the project?

This is an ongoing provision for disabled young people and their families which we do not plan to close.

- Did the funds provided by us prove adequate, or was there an over- or under-spend?

The funds made a meaningful contribution to the cost of running the scheme alongside funds from other sources.

- How were any surplus funds used, or was further funding made available?

Due to the cost of running the scheme, there were no surplus funds from the grant.

Tell us about the project

- Has the project been successful and well received by the beneficiaries?

Since your grant was received, our Guildford Youthscheme has supported 76 disabled young people across a combined 714 scheme days. Of those, 50 had 1:1 support from our highly-trained Challengers youthworkers and a further two had 2:1 support. At the same time, the families of our young beneficiaries benefited from a combined 4,284 hours of respite. Our most recent Parent Carer Survey (October 2024) emphasized the importance of offering parents moments to pause and recharge from their caring responsibilities. As one parent summarised: "It is a real lifeline for us. It gives us an opportunity for respite, knowing [our daughter] is safe and having fun. She also gets to mix with friends, which can be a struggle. Challengers is a very valued and special place. It gives us a chance to breathe."

We are happy with the outcome of the scheme and the impact it has on our young beneficiaries and their families, however we always strive to improve and take onboard feedback from our beneficiaries and their families. We collect this data through our Child Listening Programme, designed to capture the voices of children and young people, and our Parent Carer Survey, an opportunity for parents and carers to contribute meaningful insights.

The scheme is also funded by short breaks contracts with Surrey County Council, parental contributions, and voluntary income (trusts and foundations, corporate partnerships, community events, and individual giving).
